Endt. No. 1 (c) Insured Person including Spouse, Dependent Children and Dependent Parents

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon and subject to the Insured having paid the agreed extra premium, the definition of Insured Person covers employees of the Insured and their Eligible Family Members as defined below and specified in the schedule attached to and forming part of the policy.

Eligible Family Members means

1. Spouse - Spouse means the employee's legally married partner.
2. Dependent Children - Dependent Children means the employee's children or legally adopted children and
 - Who are over 90 days

Maximum of first 2 dependent children of the employee, alone are covered.

3. Dependent Parents

Any person specified in the schedule forming part of this policy but does not come within the purview of the definition of Insured person as given above, shall be deemed as uncovered and stand automatically deleted under this policy.

Endt. No. 2 (a) - Pre-existing Disease Exclusion Waiver for All Insured Persons including their dependents:

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon and subject to the Insured having paid the agreed extra premium, that Exclusion 1, 2, and 3 as mentioned below stands deleted for all Insured persons covered under this policy.

Exclusion no.1: Pre-existing diseases - Excl01

Exclusion no.2: Specified disease/procedure waiting period- Code- Excl02

Exclusion no.3: 30 days waiting period - Excl03

Endt. No. 5(i) - Limitation of Benefits - Room, Boarding expenses:

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon that the following benefits payable under the policy shall be subject to the limits as specified hereunder:

Room, Boarding Expenses as provided by the Hospital/Nursing Home is subject to a limit of **1%** of the Sum Insured per day and for Intensive Care Unit **2%** of the Sum Insured per day. In case, the insured person is admitted in a room with rent higher than the eligible room rent limit, the total hospitalization claim shall be reduced in proportion of eligible room rent to the actual room rent paid.



Endt. No. 5(ii) - Limitation of Benefits - disease, illness, medical condition or injury:

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon that,

the Claim amount payable towards the treatment of following disease, illness, medical condition or injury is subject to a limit of:

Treatment	Limit
Cataract	30% of the SI subject to a maximum of Rs.50,000/- (both the eyes)
Treatment of mental illness, stress or psychological disorders and neurodegenerative disorders	25% of the Sum Insured subject to a maximum of Rs.30,000/-
Balloon Sinsuplasty, Bronchical Thermoplasty, vaporization of prostate(green laser treatment), Intra Operative Neuro Monitoring, Intra vitreal injections	10% of the Sum Insured subject to a maximum of Rs.1,00,000/-
Stem Cell therapy - Hematopoietic stem cells for bone marrow transplant for haematological conditions to be covered	10% of the Sum Insured subject to a maximum of Rs.1,00,000/-
Oral Chemotherapy, Immunotherapy(monoclonal antibody to be given as injection)	5% of the Sum Insured per month subject to a maximum of Rs.1,00,000/- during the Period of Insurance

Endt. No. 6 - Floater Cover:

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon and subject to the Insured having paid the agreed extra premium, that the maximum liability of the Company, during the Period of Insurance, in respect of any one claim/series of claims under this policy for the Insured Persons and his Family, shall not exceed the Floater Sum Insured as given in Specification attached to the Policy.

However, where the Specification attached to the Policy indicate a per person limit besides the Family floater limit, such per person limit is the maximum amount allowable for each Insured Person subject to the overall floater limit for the family during the Period of Insurance.

Family means the member/employee and their Eligible family members covered in this policy.

Endt. No. 8 Co-payment Clause

A Co-payment is a cost-sharing requirement under a Health Insurance policy that provides that the policy holder/insured will bear a specified percentage of the admissible claim amount. A co-payment does not reduce the Sum Insured.

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon that the policy is subject to a deductible of

50% of the admissible claim in respect of any Robotic or Radiosurgery treatments like Cyberknife, Gamma Knife, etc. for diseases, illness, medical condition or injury that is otherwise not excluded under this Policy

50% of the admissible claim in respect of Cochlear implant

50% of the admissible claim in respect of Genetic Disorders

This Co-payment, shall be deducted from each and every admissible claim amount



Endt. No. 10 Corporate Floater:

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon and subject to the Insured having paid the agreed extra premium that the policy is extended to provide for a limit of Rs. **20,00,000/-** as Corporate floater during the Period of Insurance.

This Corporate floater limit shall operate after exhaustion of the Per person limit/Family floater limit provided for the Insured persons under this policy.

The maximum claim payable per Insured person / Family under this endorsement is equivalent to the Per person limit / Family floater limit provided under this policy.

However once the above mentioned limit is exhausted on settlement of claims during the Period of Insurance, no further claim shall be allowed under this Endorsement.

This corporate floater limit is not applicable for claims in respect of Benefits that has sublimit under the policy.

Endt. No. 11 (b) Maternity Treatment Charges Benefit Extension without waiting period at inception

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon and subject to the Insured having paid the agreed extra premium Maternity Exclusion - Excl18 stands deleted and the Policy is extended to cover Maternity Expenses as defined below :

Maternity Expenses shall include:

1. medical treatment expenses traceable to childbirth (including complicated deliveries and caesarean sections incurred during hospitalization).
2. expenses towards lawful medical termination of pregnancy during the policy period.

The Maternity Expenses are covered subject to the following conditions:

- I. The maximum benefit under this Benefit is limited to **Rs. 25,000/-** for Normal Delivery and **Rs. 35,000/-** for Caesarean section delivery, per family.
- II. Claims in respect of delivery for only first two children and/or operations associated therewith will be considered in respect of employee or spouse covered under the Policy or any renewal thereof. Those Insured Persons who are already have two or more living children will not be eligible for this Benefit.
- III. Expenses incurred in connection with voluntary medical termination of pregnancy during the first 12 weeks from the date of conception are not covered.
- IV. Pre-natal and post-natal expenses are covered only if the Insured Person is treated as an In-patient in a Hospital/Nursing Home.
- V. The Company will reimburse actual cost incurred subject to the limit for this Benefit, towards
 - Abnormal presentation
 - Ectopic pregnancy
 - Miscarriage
 - Missed abortion
 - Still birth
 - Post partum haemorrhage
 - Retained placental membrane
- i. No refund shall be allowed in the event of the Insured canceling this Benefit during currency of the Policy.



Endt. No. 12 Coverage for new Born baby

Newborn baby means baby born during the Policy Period and is aged upto 90 days.

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon and subject to the Insured having paid the agreed extra premium, the provisions under "Persons who can be Insured" stand modified to include the newborn baby of the Insured Person subject to a sufficient advance deposit being maintained with the company for inclusion of the baby under the Policy.

Endt. No. 16 Emergency Ambulance Expenses

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon and subject to the Insured having paid the agreed extra premium, that the policy is extended to provide for Ambulance charges in an emergency, subject to a limit of **Rs.1,500/-** per claim

Endt. No. 18 Relaxation of Age Limit

It is hereby declared and agreed that otherwise subject to the terms, exclusions and conditions contained in the policy or endorsed thereon and subject to the Insured having paid the agreed extra premium, that the provisions under "Persons who can be Insured" stand modified to include persons of age up to **89** years and not as stated in the policy.

Endt. No. 22(ii) Process for Mid-term Inclusion (for policies providing Endt no.12)

During the currency of the Policy, inclusions will be permitted for new joinees and their dependents.

Inclusion of dependants is subject to coverage provided under the policy or endorsement forming part thereof.

Existing employees and their dependents cannot be included during the currency of the Policy period except,

- newly married spouse of the existing insured employee and
- newborn child of existing insured employee

provided the policy provides cover for spouse and children.

A cash deposit is to be held by the client to effect inclusion of

- new joinees and their dependants from the date of Joining,
- newly married spouse from the date of marriage,
- new born child from the date of birth,

subject to

- o availability of sufficient premium in the deposit to effect the inclusion
- o the date of joining / date of marriage/ date of birth, is in the preceding month to the date of declaration.

In case , of any delayed declaration of the above members , the inclusion is from the date of receipt of declaration subject to availability of sufficient premium in the deposit to effect the inclusion.

If the cash deposit is not sufficient to effect the inclusion, inclusion is effected from the date of payment of premium.

Inclusion of an employee does not warrant automatic inclusion of the employee's dependents (unless agreed in the policy).

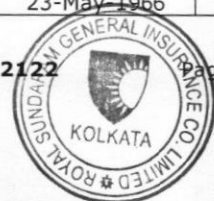

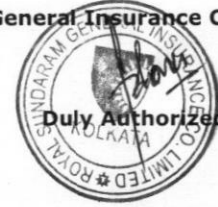
